### MOTION TO RELINQUISH RECORDING DEVICES IN CLOSED MEETING

IN ORDER TO PROTECT THE CONFIDENTIALITY OF CLOSED MEETING DISCUS-SIONS A MOTION IS NEEDED TO REQUIRE ALL SCHOOL BOARD MEMBERS PARTICIPATING IN TONIGHT'S CLOSED MEETING OF THE SCHOOL BOARD TO RELINQUISH AND HAVE STORED IN A SECURE LOCATION DESIGNATED BY THE SCHOOL BOARD ALL RECORDING DEVICES TO INCLUDE CAMERAS COM-PUTER STORAGE DEVICES, DIGITAL VIDEO RECORDERS SOUND RECORDING TECHNOLGY OR TAPE-RECORDING DEVICES.

Vice Chair Byrum moved, and Member Jenkins seconded the motion, to approve the motion as presented.

Upon a roll call vote, the vote was: Aye: 4 Nay: 0 Abstain: 0 Absent: 1 (Riddick). The motion Passed. 4 to 0. (The Clerk mistakenly did not call on Board Chair Brooks-Buck for her vote.)
